ADA Transition Plan

The Americans with Disabilities Act (ADA), enacted July 26, 1990, is a civil rights law prohibiting discrimination against individuals on the basis of disability. ADA consists of five titles, outlining protections in the following areas:

1. Employment
2. Miscellaneous Provisions
3. Public Accommodations
4. State and Local Government Services
5. Telecommunications

Redwood County must meet these general requirements for individuals with disabilities:

1. Access to all public programs and places
2. Modification of policies that deny equal access
3. Effective communication procedures
4. An ADA Coordinator that coordinates ADA compliance
5. Public notice of ADA requirements
6. Grievance procedure for resolution of complaints

As required by Title II of ADA, 28 CFR, Part 35, Section 35.105 and Section 35.150, Redwood County has developed the following ADA Transition Plan for its county roads, bridges and right-of-way. This transition plan details how Redwood County will work to ensure all its county roads, bridges and right-of-ways are accessible to all individuals. The plan contained herein relates only to the County's roads, bridges, and right-of-ways and does not include other County programs, practices, or building facilities not related to public rights of way. As such, when this document makes reference to "County owned facilities" or "County programs, services, and activities" it shall only apply to the County's roads, bridges, and right-of-ways.

A systematic approach to providing accessibility will be taken in order to responsibly complete reconstruction of public facilities within County road right-of-way in order to comply with ADA requirements. The County will make all reasonable modifications to policies and programs to ensure that people with disabilities have an equal opportunity to enjoy all of its' programs, services and activities. ADA does not require the County to take any action that would fundamentally alter the nature of its programs or services, or impose an undue financial or administrative burden. Redwood County's goal is to provide ADA accessible pedestrian design features as part of the County's road and bridge reconstruction projects.

1. The Redwood County Highway Department has identified physical obstacles in its facilities that limit the accessibility of its programs or activities to individuals with disabilities. In 2017 the Highway Department conducted a self-evaluation and surveyed all of all of its' 544 intersection quadrants and pedestrian ramps within population centers and which could contain pedestrian facilities. At that time the Highway Department noted 528 quadrants that either did not have pedestrian facilities or were non-compliant, including not having a curb ramp, drainage issues, missing truncated domes, out of tolerance slope, cracked joints or disconnected sidewalk. From 2017 to 2022, the Highway Department has made improvements to 112 intersection quadrants and thousands of lineal feet of sidewalks, improving 20% of all facilities.

2. The Redwood County Highway Department will continue to reconstruct out of compliance curb ramps and pedestrian facilities within its right-of-way during future, programmed road and bridge reconstruction projects. ADA improvements on any County road rehabilitation or resurfacing project will be addressed on a case-by-case basis. ADA improvements requested by the public will be evaluated by County staff. Evaluation criteria will include pedestrian volumes, traffic volumes, condition of existing infrastructure, public safety and available funding.

Redwood County intends to construct or upgrade curb ramps, sidewalks and trails to achieve compliance. There may be limitations which make it technically infeasible for a facility to achieve full accessibility within the scope of any project. Those limitations will be noted and the facility will remain on the transition plan. As future reconstruction projects or funding opportunities arise, those facilities will continue to be incorporated into future work. Regardless of whether full compliance can be achieved or not, each facility shall be made as compliant as possible to industry standards in accordance with the professional judgement of County staff.

Financing of the pedestrian facility reconstruction will be through local funds, State Aid construction funding, federal funding, and through local City and Tribal partners per existing maintenance and construction agreements, or future agreements if new terms are agreed upon at a later date.

The timing and schedule of future reconstruction projects is outlined in the current Redwood County Highway Department Five Year Plan. The Five Year Plan is updated regularly and lists the projects the Department intends on completing in the next five years. The plan is intended to be flexible, recognizing road and bridge priorities may shift due to rapid changes in highway and bridge conditions, public input, goals, priorities and budget constraints. County roads identified for reconstruction in the Five Year Plan will be ADA compliant at the completion of the plan. Reconstruction projects completed within the last five years include county road work in the cities of Redwood Falls, Morgan and Clements. After 20 years, Redwood County will be 45 percent compliant, after reconstruction in Belview, Vesta and another community yet to be selected based on age and condition of existing infrastructure. Approximately one municipal county road reconstruction project occurs every five years in Redwood County based on available funding.

3. The Redwood County Highway Engineer is the official responsible for implementation of this plan.

Cost Information:

Construction costs for upgrading facilities can vary depending on each individual improvement and conditions of each site. Costs can also vary on the type and size of the project the improvements are associated with. The 2022 construction cost for a single typical pedestrian ramp reconstruction is \$4,452, which includes curb and gutter, 6" thick concrete walk, excavation, aggregate base, truncated domes, seeding, fertilizer, erosion control blanket, mobilization and traffic control. The estimated cost to complete all remaining intersection quadrants in Redwood County is \$1,852,021. This cost does not include replacement of non-compliant sidewalks and trails.

Public Outreach:

A Public Hearing to receive public comment on the ADA Transition Plan was held at 8:30 am on October 18, 2022 at the Redwood County Board Meeting in Redwood Falls. Advertisements for the public meeting were published in local papers prior to the meeting and the hearing date was set at the September 20, 2022 Redwood County Board Meeting. The Redwood County Highway Engineer additionally held three County Board workshops on January 19, 2021, April 13, 2021 and on June 15, 2021 and held Public Hearings at four City Councils meetings on May 3, 2021 (Lucan), May 11, 2021 (Belview), June 7, 2021 (Clements) and on June 14, 2021 (Walnut Grove). Advance notice of these seven meetings were published in local papers prior to the meeting dates.

Appendix A – Redwood County ADA Public Notice

As part of the ADA requirements the County has posted the following notice outlining its ADA requirements:

In accordance with the requirements of Title II of the Americans with Disabilities Act of 1990, Redwood County will not discriminate against qualified individuals with disabilities on the basis of disability in County's services, programs, or activities.

Employment: The County does not discriminate on the basis of disability in its hiring or employment practices and complies with all regulations promulgated by the U.S. Equal Employment Opportunity Commission under Title I of the Americans with Disabilities Act (ADA). The County's Personnel Policy governs employment-related complaints of disability discrimination.

Effective Communication: The County will generally, upon request, provide appropriate aids and services leading to effective communication for qualified persons with disabilities so they can participate equally in the County's programs, services, and activities, including qualified sign language interpreters, documents in Braille, and other ways of making information and communications accessible to people who have speech, hearing, or vision impairments.

Anyone who requires an auxiliary aid or service for effective communication, or a modification of policies or procedures to participate in a County program, service, or activity, should contact the office of ADA Coordinator, as soon as possible but no later than 48 hours before the scheduled event.

The County will not place a surcharge on a particular individual with a disability or any group of individuals with disabilities to cover the cost of providing auxiliary aids/services or reasonable modifications of policy.

Modifications to Policies and Procedures: The County will make all reasonable modifications to policies and programs to ensure that people with disabilities have an equal opportunity to enjoy all County programs, services, and activities.

The ADA does not require the County to take any action that would fundamentally alter the nature of its programs or services, or impose an undue financial or administrative burden.

Appendix B: Redwood County Grievance Procedure under the Americans with Disabilities Act

Prior to filing a grievance the public is strongly encouraged to contact the Redwood County ADA Coordinator to discuss any concerns regarding County facilities. The ADA Coordinator role is designed to provide a point of contact for the public to address concerns.

This Grievance Procedure is established to meet the requirements of the Americans with Disabilities Act of 1990 ("ADA"). It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, programs, or benefits by the Redwood County Highway Department. The County's Personnel Policy governs employment-related complaints of disability discrimination.

The complaint should be in writing and contain information about the alleged discrimination such as name, address, phone number of complainant and location, date, description of the problem and the nature of a remedy sought, if known by the complainant. If the complainant has filed the same complaint or grievance with the United States Department of Justice (DOJ), another federal or state civil rights agency, a court, or others, the name of the agency or court where the complainant filed it and the filing date should be included. Alternative means of filing complaints, such as personal interviews or a tape recording of the complaint, will be made available for persons with disabilities upon request.

The complaint should be submitted by the grievant and/or his/her designee as soon as possible but no later than 60 calendar days after the alleged violation to:

Within 60 calendar days after receipt of the complaint, the ADA Coordinator or designee will meet with the complainant to discuss the complaint and the possible resolutions. Within 15 calendar days of the meeting, the ADA Coordinator or designee will respond in writing, and where appropriate, in a format accessible to the complainant, such as large print, Braille, or audio tape. The response will explain the position of the Redwood County Highway Department and offer options for substantive resolution of the complaint.

If the response by the ADA Coordinator or designee does not satisfactorily resolve the issue, the complainant and/or his/her designee may appeal the decision within 15 calendar days after receipt of the response to the County Administrator or his/her designee.

Within 60 calendar days after receipt of the appeal, the County Administrator or his/her designee will meet with the complainant to discuss the complaint and possible resolutions. Within 30 calendar days after the meeting, the County Administrator or his/her designee will respond in writing, and, where appropriate, in a format accessible to the complainant, with a final resolution of the complaint.

All written complaints received by the ADA Coordinator or designee, appeals to the County Administrator or designee, and responses from these two offices will be retained by the County in accordance with state and federal law.

Those wishing to file a formal written grievance with Redwood County may do so by one of the following methods:

Internet Submittal: Visit the Redwood County Highway Department's website at: <https://redwoodcounty-mn.us/departments/highway-department/> and click on the link to the ADA Transition Plan, complete the grievance form in Appendix C and email to rchd@co.redwood.mn.us.

In Person Submittal: Contact the County Highway Engineer at 507-637-4056. The staff person will utilize the Internet method above to submit the grievance on behalf of the person filing the grievance.

Paper Submittal: Contact the Redwood County Highway Department at 507-637-4056 or rchd@co.redwood.mn.us to request a paper copy of the county's grievance form, complete the form, and submit it to the ADA Coordinator at 1820 East Bridge Street, Redwood Falls, MN 56283.

If the grievance filed does not concern a Redwood County facility, the County will inform the complainant of the proper agency that has jurisdiction.

Within 60 calendar days of receipt, a Redwood County staff person will conduct an investigation necessary to determine the validity of the alleged violation. As a part of the investigation, the staff person may conduct an engineering study to help determine the County's response. The staff person will take advantage of department resources and use engineering judgment, data collected, and any information submitted by the resident to develop a conclusion. A staff person will be available to meet with the complainant to discuss the matter as a part of the investigation and resolution of the matter. The County will document each resolution of a filed grievance and retain such documentation in accordance with state and federal law.

The County will consider all specific grievances within its particular context or setting. Furthermore, the County will consider many varying circumstances including: 1) the nature of the access to services, programs, or facilities at issue; 2) the specific nature of the disability; 3) the essential eligibility requirements for participation; 4) the health and safety of others; and 5) the degree to which an accommodation would constitute a fundamental alteration to the program, service, or facility, or cause an undue hardship to Redwood County, and 5) available funding.

Accordingly, the resolution by Redwood County of any one grievance does not constitute a precedent upon which the county is bound or upon which other complaining parties may rely.

File Maintenance: The County shall maintain ADA grievance files in accordance with state and federal law. Complaints of Title II violations may also be filed with the DOJ within 180 days of the date of discrimination. In certain situations, cases may be referred to a mediation program sponsored by the Department of Justice (DOJ). The DOJ may bring a lawsuit where it has investigated a matter and has been unable to resolve violations.
