# MARCH 1, 2022

The Board of County Commissioners met in regular session at 8:30 a.m. in the Commissioner's Room in the Government Center, Redwood Falls, Minnesota.

WHEREAS, the County acknowledges advance funds are released on a first-come-first-serve basis and this resolution does not guarantee the availability of funds.

NOW, THEREFORE, BE IT RESOLVED: That the Commissioner of Transportation be and is hereby requested to approve this advance for financing approved County State Aid Highway Project(s) of the County of Redwood in an amount up to \$1,232,934 in accordance with Minnesota Rules 8820.1500, Subp. 9. I hereby authorize repayments from subsequent accruals to the Regular Construction Account of said County from future year allocations until fully repaid.

This Resolution shall be effective immediately and without publication.

#### **RESOLUTION 2022-01**

# A RESOLUTION TO EXPEND CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS UNDER THE AMERICAN RESCUE PLAN ACT FOR SOIL AND WATER CONSERVATION DISTRICT WATER RETENTION PROJECT

WHEREAS, Redwood County ("County") received Federal Coronavirus Local Fiscal Recovery Funds under the American Rescue Plan Act ("ARP"), to provide relief to the county impacted by the coronavirus disease 2019 ("COVID-19");

WHEREAS, Redwood Soil and Water Conservation District Administrator, Scott Wold has identified a necessary expense to manage storm water in the cities of Vesta and Walnut Grove, located within Redwood County, to protect city infrastructure and downstream property, and improve water quality;

WHEREAS, the authority under the ARP Act allows this expenditure, per the Department of the U.S. Treasury Frequently Asked Questions ("FAQ") dated January 2022; under Section 6.1,

paragraph 1 and 3:

6.1. What types of water and sewer projects are eligible uses of funds? The Interim Final Rule generally aligns eligible uses of the Funds with the wide range of types or categories of projects that would be eligible to receive financial assistance through the Environmental Protection Agency's Clean Water State Revolving Fund (CWSRF) or Drinking Water State Revolving Fund (DWSRF).

Under the CWSRF, categories of eligible projects include: construction of publicly owned treatment works, nonpoint source pollution management, national estuary program projects, decentralized wastewater treatment systems, storm water systems, water conservation, efficiency, and reuse measures, watershed pilot projects, energy efficiency measures for publicly-owned treatment works, water reuse projects, security measures at publicly-owned treatment works, and technical assistance to ensure compliance with the Clean Water Act.

WHEREAS, the storm water project in Walnut Grove has an engineered cost estimate of \$184,000, and 75% of the cost has been identified through existing state funds, and the remaining 25% of the project cost will be provided by ARP funds;

WHEREAS, the storm water project in Vesta has an engineered cost estimate of \$25,000, and 25% of the cost has been identified through local commitment, and the remaining 75% of the project cost will be provided by ARP funds;

**NOW, THEREFORE, BE IT RESOLVED,** the County Board of Commissioners is encumbering \$65,000 to be used to complete the two identified storm water projects and certifies that the funds appropriated from the ARP Act fund will be used only in a manner consistent with the Department of the U.S. Treasury guidance and incurred during the covered period.

- Chair Salfer appointed Commissioner Forkrud Redwood County Ditch Authority interim chair.
- On motion by Salfer, second by Van Hee, in a roll-call vote with Salfer, Van Hee and Forkrud all voting aye, the Board voted to adopt the following amended resolution:

WHEREAS, Various Joint County Drainage system accounts have insufficient funds to pay the expenses incurred in maintaining the efficiency of the drainage systems; and WHEREAS, Minnesota State Statutes 103E.655, Subdivision 2 provides that the County Drainage Authority may transfer funds from other drainage system accounts under its jurisdiction. # PUBLIC HEARING - COMMERCIAL SOLAR GARDEN MORATORIUM

- At 10:25 a.m., the Redwood County Board of Commissioners entered into a Public Hearing for the presentation of a Commercial Solar Garden Moratorium.
- Brozek presented the Affidavit of Publication. Present were Redwood County Commissioners Forkrud, Salfer and Van Hee, Administrator Kletscher, Planning and Zoning Supervisor Brozek and Nathan Dull and Alex Pouliot of Minnesota Land and Liberty Coalition.
- An overview of the Draft Interim Commercial Solar Garden Ordinance was presented by Brozek
- Chair Salfer opened the Public Hearing for public comment. Pouliot stated the Minnesota Land and Liberty coalition is in opposition of a moratorium as they believe the landowner should have the right to decide what to do with their land. He also wanted to know what the plan would be after the one year Moratorium expires.
- Salfer stated the Moratorium is intended to provide the opportunity for Redwood County to research the pros and cons of allowing future solar gardens in Redwood County. The Moratorium can be lifted at any time if a permit would be filed in Redwood County and the Board feels the Solar Garden is a viable project.
- On motion by Forkrud, second by Van Hee, the Board voted unanimously to adopt the Commercial Solar Garden Moratorium.
- The Public Hearing was closed at 10:37 a.m.
