MINUTES
Meeting Date: July 30, 2024



A meeting of the Redwood County Planning Commission convened on Tuesday, the 30th day of July, 2024, at the Redwood County Government Center.

The following members of the Redwood County Planning Commission were present: Mike Kaufenberg, Mark Madsen, Jeff Huseby, Ed Carter, Mike Scheffler, and County Commissioner Dave Forkrud. At 1:03 p.m. the July 30, 2024, Redwood County Planning Commission meeting was called to order by Chair Madsen.

Chair Madsen read the Planning Commission rules and procedures. Printed copies were available to the public.

At 1:06 p.m. Chair Madsen called to order a public hearing on Animal Confinement Feedlot Conditional Use Permit Application #7-24, submitted by Kyle Prechel.

Prior to the Planning Commission meeting, the Planning Commission members were provided an informational packet, which included the following information regarding the matter:

- Kyle Prechel is seeking to operate a 744-animal unit cattle operation the East Half of the Northwest Quarter
 of Section 21 of Willow Lake Township. The feedlot would consist of four barns and three open lots to house
 125 cow/calf pairs, 70 feeder cattle, and 545 fat cattle. [The packet was updated at the start of the meeting
 to correct the numbers of the proposed feedlot expansion to a final count of 890 animal units, consisting
 of 125 cow-calf pairs and 740 fat cattle.]
- 2. The site is located in the "A" Agricultural District. A feedlot over 300 animal units is a conditional use in said District.
- 3. The current feedlot is under 300 animal units. There are three existing barns and two open lots on the property, and Prechel proposes to add one 50'x336' barn, one 50'x200' holding pen, a 32'x50' processing facility, and two manure bays to the existing operation.
- 4. The nearest county open ditch is 1,575 feet north of the site, and the nearest county tile line is 1,375 feet northwest of the site. Willow Lake is 4,000 feet west of the site.
- 5. The three closest residential dwellings to the site, other than the landowner, are as follows:

 Shelly and Shawn Willhite, 30479 County Hwy 4, about 1,900' north of the site;

 David Eichten, 18444 Knox Ave., about 2,100' southeast of the site;

 and Dale and Marlene Jenniges, 29844 County Hwy 4, about 2,575' southwest of the site.
- 6. Redwood County Code of Ordinances requires feedlots to meet or exceed a 93% annoyance free rating on the University of Minnesota Odor OFFSET model.

- 7. The ratings for the proposed feedlot to the nearest residences are as follows:
 - (1) 30479 County Hwy 4 97%
 - (2) 18444 Knox Ave. 98%
 - (3) 29844 County Hwy 4 98%
- 8. A copy of the Conditional Use Permit application, maps, plans, and proposed permit conditions were enclosed.

Kyle Prechel and Samantha Prechel were in attendance to present the project to the Planning Commission. Kyle Prechel made the following statements to the Commission:

- He would like to add a 50'x336' hoop barn and expand his feedlot numbers.

Pidde noted that the application was updated to reflect a final animal unit number of 890, including 125 cow/calf pairs and 740 fat cattle, which is a higher total animal units number than on the original application. An updated manure management plan was also provided.

Samantha Prechel noted that they met with Jason Kaare of MPCA at the site the day before, and everything was updated.

The Planning Commissioners had the following questions and comments:

- Does the site already have a CUP?
- Can you explain how the manure is handled?
- Will the manure bays be covered?
- What is the capacity of the manure storage?
- Are they utilizing temporary stockpiles?
- Will they spread manure in fall, or when they can? Is it a larger amount?
- Did they read through the proposed conditions?

Pidde responded that the site does not have an existing CUP, because it is currently under 300 animal units.

Prechels responded that:

- Manure will be piled in the manure bays and then hauled to the field, to temporary stockpiles.
- The open lots will have a manure pack that will be scraped around twice per week and put in the manure bay or stockpiled in the field, away from the tile lines.
- The concrete manure bays are covered and lower in the ground.
- There are 2 months of storage, and then it is moved to temporary stockpiles in the field.
- The manure will be spread and incorporated when they can. It is a larger amount, so they won't spread seasonally.
- The proposed conditions are fine.

Chair Madsen asked if anyone was present to speak in support of the project. No one came forward. Chair Madsen asked if anyone was present to speak in opposition to the project. No one came forward.

Chair Madsen then closed the public hearing at 1:13 p.m.

Chair Madsen directed Pidde to lead the Commissioners through the Findings of Fact Worksheet. The Planning Commissioners discussed the factors.

Scheffler made a motion to approve Animal Confinement Feedlot Conditional Use Permit Application #7-24, subject to the conditions proposed by staff. The motion was seconded by Carter and passed unanimously.

At 1:18 p.m. Chair Madsen called to order the continuation of the public hearing on Application for Extraction Interim Use Permit #6-24, submitted by Rodney Paskewitz of Duro Rock Supply Co., on behalf of landowner Artesian Properties LLC.

Prior to the Planning Commission meeting, the Planning Commission members were provided an informational packet, which included the following information regarding the matter:

- 1. The Duro Rock Supply Co. application was originally considered at the June 25th Planning Commission meeting, at which time it was tabled until July 30th, in order to allow for more information gathering.
- 2. To recap, Duro Rock is seeking to open a granite quarry in Section 18 of Swedes Forest Township. Specifically, Duro Rock's operations will be located in part of the Southwest Quarter of the Southwest Quarter (SW¼ SW¾). The proposed project area includes approximately 10 acres of granite extraction and approximately 5 acres of boulder extraction. The topsoil will be stripped off and stockpiled for reclamation. The granite material will be mined through blasting or cutting. Duro Rock is seeking a 10 year permit.
- 3. There are wetland areas on the parcel and two plant species of note: Oregon Woodsia is state-listed as a special concern plant, and Wolf's spikerush is state-listed as threatened. Duro Rock will pursue a Threatened and Endangered Species Avoidance Plan and coordinate with the DNR regarding the threatened plant species found on the site. Duro Rock will also pursue a Wetland Conservation Act (WCA) No Loss Wetland Application to determine the wetland impacts, if any, and any needed replacement plan.
- 4. At the June meeting, various concerns were brought up by members of the public in connection with the proposed quarrying. These included, but were not limited to, the following: Noise levels from blasting, crushing, and operating machinery Environmental concerns regarding ground and surface water quality and wells Public safety from increased truck traffic on the roadway
- 5. Information was gathered by staff to address these concerns, from various sources, including the MN Department of Health and Redwood County Highway Engineer.

Noise

The MPCA published "A Guide to Noise Control in Minnesota," in 2015. For residential locations (including farm houses), the daytime (7 a.m.-10 p.m.) noise limits are 65 dBA for not more than six minutes per hour (10% of the time) and 60 dBA for not more than 30 minutes per hour (50% of the time) for non-impulsive noises. Local governments "are required to take reasonable measures to prevent the approval of land use activities that will violate the state noise standard immediately upon establishment of the land use (Minn. R. 7030.0030)." Generally, doubling the distance from a noise source reduces the sound level by 6 decibels. Doubling the source of the sound increases the measured sound by 3 decibels.

Lauren Dickerson with the Air Policy Unit of MPCA stated that there are no standards to address impulsive noise, and there's no definition for an impulsive noise that would constitute a nuisance.

She referred to an MPCA report for guidance entitled, "Environmental Impulse Noise Study" from 1991. According to the report, "There are occasions when very loud and disruptive levels of noise are present, but do not last long enough to violate the L10 limit during an hour. These events may be referred to as short term, or impulse noise events. Some examples include: back up alarms, whistles, horns, bells, sirens, fireworks, gunfire, blasting, pile-driving, riveting, hammering, stamping, rail car coupling, sonic booms, aircraft flyovers, and dogs barking." The report examines a few other states' laws that address impulsive noises. Some of the states mentioned had exceptions to limitations on impulsive noises, including back-up alarms and blasting. The report concluded, "Researchers disagree widely on the intrusive effects of environmental impulse noise. There is no clear evidence of any permanent physical effect on the public's health from environmental impulse noise at this time."

An article entitled, "A synthesis of two decades of research documenting the effects of noise on wildlife" published in Biological Reviews by Cambridge Philosophical Society in 2015, examined the scientific literature published from 1990 to 2013 on the effects of anthropogenic noise on wildlife. Two-thirds of the data focused on songbirds and marine mammals, and the majority of studies documented effects from noise, including altered vocal behavior to mitigate masking, reduced abundance in noisy habitats, changes in vigilance and foraging behavior, and impacts on individual fitness and the structure of ecological communities. Biological responses can differ between species. In one study, the number of species of nesting birds was reduced due to anthropogenic noise, but birds that could tolerate noisier habitats had higher numbers due to reduced predation. Reptiles, amphibians, and invertebrates are underrepresented in the research.

Wells

A representative of the Minnesota Department of Health recommended that the homeowners have their wells tested now so that they could document any water quality changes after mining begins. She stated that she did not know specifically what contaminants may be impacted by mining, and it depends on the geology of the area. Arsenic and manganese are from the geology and most likely to be impacted. She also stated that there could be cloudiness if sediment is disturbed.

The DNR Area Hydrologist, Kyle Jarcho, stated in a phone conversation that in determining whether or not to grant a water appropriations permit, they look at everything in the area that would be affected, including wells, aquifers, and wetlands.

Traffic

Anthony Sellner, Redwood County Highway Engineer, stated that the commercial entrance should be moved out of the no passing zone (moved to the east) for driver safety, or they should hire an engineer to review that proper sight distances will be achieved. They will need to work with the highway department on any new entrance.

Rod Paskewitz was in attendance to present the application to the Planning Commission. He made the following statements to the Commission:

- The Planning Commission had asked for more information about blasting, wells, and wildlife, and the neighbors would like to see an EAW [Environmental Assessment Worksheet]. With an EAW, engineers would come and present as well.
- It is a clearer path to move forward with an EAW to address the questions, so the quarry doesn't infringe on people's rights.
- He wanted to sit down with neighbors to discuss the situation. He wants to capitalize on the resource and make money, but he doesn't want to destroy the livelihood of others. He wanted to talk about

days/weeks/months of operation and working hours. They didn't want to sit down and talk. He offered to sell the property to the neighbors so they could keep it "wild and free," for \$3.5 million, which is a lot, but a fraction of what would be made, and they denied that offer.

- Does the planning commission believe that an EAW would help them make an educated decision?

The Planning Commissioners had the following questions and comments:

- What will the EAW tell us? (Madsen)
 - Scheffler responded that an EAW covers everything, but it's a roll of the dice for Paskewitz, since
 it involves every agency. It's extensive. It can take six months to years to complete. He doesn't
 know the cost. Right now there are a lot of hypotheticals, and he needs proof. He thinks it's good
 for the Planning Commission to know.
- Madsen referred to a letter received from CURE requesting an EAW. (Letter provided)
 - Paskewitz responded that he would like to know if he should do the EAW. It would be on the Yellow Medicine County side and Redwood County side.
- Is blasting covered by an EAW? (Huseby)
 - O Scheffler responded that it would all be in there, including noise, dust, and traffic concerns.
- Forkrud stated that regardless of the EAW, he's against the project.
 - o Paskewitz asked how that fit in with the law.
 - Madsen responded that he assumed Forkrud's statement reflected that the decision is also based on how the project affects the community.
 - Paskewitz responded that the EAW would attach to the property, so it would be available to address concerns now and in the future.

Chair Madsen asked if anyone was present to speak in support of the project. No one came forward.

Chair Madsen asked if anyone was present to speak in opposition to the project. The following individuals spoke:

Nick Lecy

- He owns the land directly north of the subject property.
- There's a dam that controls the water flow. When the dam was put in, they worked with Soil and Water Area II out of Marshall. The engineer did a measurement of the water level of the wetland, and it is 924'. He's concerned with the water runoff into the wetland.
- There are two outlets from the wetland: one through the dam and one through the neighbors' property to the Minnesota River.
- These concerns would probably be covered in the EAW.

Kari Rigge

- She's the owner of Grandview Winery and a former employee of Martin Marietta quarry in Granite Falls. She set up their management system and is familiar with blasting. It was done by a 3rd party company with an emulsion of fertilizer and diesel. They would fill holes, set up a seismograph, and blast between noon and one. There were cracks in foundations of homes closer to the blasts. At the time of blasting, production was halted, and employees took cover under a pay-loader bucket. Fly rock broke through roofs. One time, fly rock went 3 miles and smashed into a shack.
- She's very concerned for blasting. They would have to stop traffic at the intersection of the highway and two gravel roads during blasting.
- The quarry could affect the wells. The winery uses water for sanitation, wine production, and food service. They serve the public. Their well is 440' deep. 300' of bedrock. They did hydro-fracking and now have plentiful water. If a tremor shuts off or redirects water, they can't be open or produce wine. They have 38 part-time employees.

• She supports the request for an EAW to decide what's right.

Joey Lecy

- He grew up on the land where the quarry is located. There was mining in the 1970s. Who owns the mining and mineral rights? (Letter provided)
 - o Brozek responded that it would be in the property record.
- Silica dust would make his well undrinkable.
 - o Pidde asked if that is harmful if it's in the wells, or if it's only inhaled silica that is harmful.
 - Scheffler asked what the silica content of this granite is. The EAW would address this.
 - o Huseby stated that his well is shallow, and is basically made up of surface water.
- Who is responsible for the wells? The DNR?
 - o Brozek responded that the DNR is responsible for the Water Appropriations Permit.
 - o Pidde responded that the area hydrologist for the DNR stated that they look at the wells and aquifers when they issue a Water Appropriations Permit.

Mike Preuss

- He lives up the hill from the site and can plainly see it out his bedroom window.
- A real estate appraiser from Marshall says that the property value of nearby houses would likely decrease. (Letter provided)
- It could be difficult to get financing with FHA, because the appraiser must consider sources of noise, depth and extent of mining operation and mineral rights, industrial sites and negative value.
- There are 2 homes and 1 cabin and 80 acres of wilderness within 1,000 feet of the quarry; 11 houses, 2 cabins, and a vacation rental that would be negatively affected for property value.
- He urges the board to deny the permit and approve CURE's request for an EAW.

Peg Furshong

- She works for CURE and is an area resident. She lives on a farm in Renville
- Are permits required before the meeting? What's required that's not in the application? It seems incomplete.
 - o Brozek responded that the required permits are dictated by county ordinance and state statute.
- She asked numerous people to see when the mine was operational. Swede's Scientific and Natural Area was established and businesses were established in the last 50 years since it was last mined.
- There was a huge difference between what Paskewitz paid and what he offered to sell it for.
- The decision on this permit affects other residents' ability to ranch/farm/garden and tourist opportunities. Were those there when the quarry was operational?
- An EAW will look at air and water concerns and make sure things are in place.
 - Madsen asked, "What is CURE?"
 - Furshong replied that they have several offices, she works in Montevideo. They're an organization
 in the Minnesota River valley and they address climate, energy, water, and rural democracy.
 There is a staff of 14. They are involved in the CO2 pipeline process and local communities.

Ben Lecy

- He's strongly opposed. (Letter provided)
- He's deeply concerned about critical habitat.
- His well is 435' deep, and if his well goes dry or the flow is slowed, who takes care of that?
 - Brozek responded if one person causes another harm, they're responsible.
- What is the cost if his well goes dry? What protects him if Paskewitz goes bankrupt? Where's his guarantee that he'll have the same quality and flow?

- o Madsen responded that it would be a civil matter.
- An EAW is crucial, but it doesn't guarantee safety. Accidents happen.
- Will his property value go down?

Deb Dirlam

- Dakota Sioux Community requests an EAW (Letter provided)
- The Minnesota River valley is Dakota homelands. There are historical and cultural sites.
- A 106 review should be included to look for historical and cultural sites.
- The state historic preservation officer, Lower and Upper Sioux tribal historic preservation officers should be consulted in the EAW.
- Granite outcrops have microbiomes with cacti and special plants

Shane Schofield

- He owns 109 acre hunting property.
- He is opposed to the project due to the noise and dust, regardless of what the EAW might say.
- The MN Wild and Scenic River Act classified river segments that should have minimal surface disturbance. Taking rock outcroppings wouldn't be allowed.
- There are rare plants and animals, such as cactus and 5-lined skink.
- It's morally wrong for one person to profit while others sacrifice.

Alan Berends

- He has a family farm west of the site. His wife's family has lived in the area since 1867.
- He was water concerns. Once groundwater is destroyed, it's not coming back.
- His grandchildren pick sheds from deer on the property, and there's good deer hunting.
- There were 130 turkeys one winter. There's wildlife such as eagles.
- What's the definition of Rural Vacant Land it's unimproved no agricultural activity. There's usually cattle out there.
 - Pidde responded that Rural Vacant Land is the tax classification, and has no bearing on the proceeding. The Minnesota noise statute that Berends was referring to has to do with the listener's land classification based on the statute, not the county tax records.
- He's concerned about water and noise. He can hear quarries 2 miles away. The permit was denied in 2015, and that time they were proposing wire cutting. This time they're proposing crushing.
- There's not much protection from the well going dry. Pumping 200 gal/minute rate is a lot of water. How often does the DNR check this?
 - Brozek responded that he has to ask the DNR.
- He has family within a mile or two, and this will be "hanging over their heads."
- A jackhammer on a pay-loader would be noisier than the blasting.
- He likes guiet and solitude.
- There are no guarantees the wells won't go dry, and his great-grandkids will still be here and have to deal with that.

Deidra Lecy

- She is a nearby landowner, about 4,000 feet from the property. She got signatures from neighbors, Upper Sioux Environmental Director, and CURE put out a petition in opposition that got 526 signatures in 6 days. (Petition provided)
- Paskewitz hasn't presented necessary permits for the request to be considered.

- She typed up information she thought should be included in fact finding at the last meeting. (Typed list provided)
- She has a letter of concern regarding inconsistencies in the permit application (Letter provided)
- The Granite Area Arts Council and an art teacher use the back 80 (Letters provided).
- She brought in art and displayed on the table so others can see what's produced from the area.
- Mining would end education and arts in the area.
 - o Madsen asked about her proximity to the Duininck mine.
 - Lecy responded that there is noise from the crusher. Sometimes there's a rumble. They process
 wet aggregate, so it's not dusty. The proposed quarry is up on the hill and winds will bring the
 noise and dust down to her property. Duinincks has cedar and oaks to protect from the noise.
 When trees were taken down along her driveway, the road sound doubled.
- She has extensive gardens and donates food. She wouldn't feel safe donating the produce if the permit is approved.
- She supports the EAW, but still thinks the permit should be denied.

Jeff Huseby

- Paskewitz made an effort to get together and asked him to make a proposal to sell. There was a
 conversation about the offer to buy, but they can't afford his asking price. They didn't reject the offer,
 they just couldn't afford it.
- There's a lot of history and dedication to the area.
- There's concern about wells, noise, and dust. He doesn't condemn Paskewitz for trying to make a living, but others in the area also have that right and spent a lot of money putting in the wetland, and they're passionate about it.

Chair Madsen then closed the public hearing at 2:33 p.m.

Kaufenberg made a motion to table the application for Extraction Interim Use Permit #6-24 until after the EAW is completed. Carter seconded the motion, and it passed unanimously.

The Commissioners reviewed and discussed the minutes from the June 25, 2024, Planning Commission meeting. Kaufenberg made a motion to approve the June 25, 2024, Planning Commission minutes. Carter seconded the motion, and it passed unanimously.

Following a motion by Carter and second by Huseby, with all in favor, the meeting was adjourned at 2:44 p.m.

Re: Application for Extraction Interim Use Permit for Duro Rock Supply Co. – Swedes Forest Quarry

Dear Redwood County Planning Commission,

We write to you today to urge you to order an environmental review for the Swedes Forest Quarry project proposed by Duro Rock Supply Co. Over 500 people—most of which live and work in the area surrounding the proposed project—have signed a petition asking this Commission to deny the company's Application for Extraction Interim Use Permit. We share their concerns about the proposed project's potential environmental and human health impacts, including:

- Depletion of water resources, including surface waters and wells, due to the project's operational needs;
- Pollution of critically important wetlands directly adjacent to the proposed project from runoff:
- Emission of harmful air pollutants, including silica dust,¹ from extraction activities;
- Disruptive or damaging vibrations and explosions from blasting and sawing to extract granite;
- Increased truck traffic on local roads; and
- Negative impacts on local businesses.

Pursuant to the Redwood County Code of Ordinances Title 15, Section 153.282(B)(3)(g), the County should order an Environmental Assessment Worksheet (EAW) when "a project generates valid public questions or controversy concerning possible environmental effects due to

the proposed action." Clearly, given the extensive engagement of over 500 individuals, there is significant controversy over the proposed project's potential environmental effects.

To have a complete understanding of the project's potential impacts, to protect the health and wellness of the local community and environment, and to avoid potential legal action, the Commission should recommend that the County Board of Commission to require the preparation of an Environmental Assessment Worksheet.

To Whom it May Concern:

Please consider my concerns for denying the permit for Rodney Paskewitz, Duro Rock

I grew up on the proposed site and would like to inform you that Delano Granite Works Inc. Worked the quarry in the 50's then it was abandoned. In the 70's Delano Granite Works came in burnt, and plugged some of the large rock and shipped it out. Do they still own the mineral rights and mining rights? Does the board know who owns the mineral and mining rights?

My concern is the quarry hasn't been in operation since the 70's. I feel the history of the rock needs to be researched. Is this rock too difficult to blast, cut, and crush or does it create too much silica dust. Which is a toxin to the environment.

I have lived in this area for 62 years and am happy to have raised my children and now grand children to learn and appreciate the natural habitat surrounding us. Jimmie and Joyce Lecy (my parents) along with our neighbors have developed the wetlands with a manmade earthen dam that maintains a estimated 60 acres of typed 5 wetlands. We protect the wetlands and habitat that have become more abundant in the last 10 years. The Trumpeter Swan's that have nested here for the last five years is a testament to the perfect ecosystem that was created. The DNR website states they are both protected by state and federal law.

Our family regularly uses the land just north and east of the proposed quarry year-round. Having silica dust blown into the air and leeched out of the water by running it through the grass will not be an ethical practice, effective, or environmentally friendly way to do business for any amount of dollars it may generate.

Another concern of mine is I have a very shallow well. If something were to happen to mine or anyone else's well who is responsible for paying for the damages? Most likely the DNR will not foot the bill for a new well. That should be on the landowner who hired the company to blast.

Lastly, please deny the permit due to the lack of permits, lack of wildlife and water quality study and consideration for the neighbors to keep our Valley Scenic and our Minnesota River clean.

Re: Duro Rock's conditional use permit for a rock quarry in Swedes Forest Township

Upon understanding the facts of the matter through conversation with homeowner Michael Preuss it is my opinion that if this conditional use permit were granted and operations to remove material from this quarry commenced and were active it is highly likely and most probable that the value of the nearby homes would be negatively impacted.

External obsolescence is a type of depreciation that occurs when factors outside of a property negatively affect its value. These factors can be environmental, social, or economic. External obsolescence is a key factor in property valuation as it can significantly impact a property's marketability and profitability.

In this case the rock quarry and operation to remove materials would be considered an external obsolescence which had negative impact on a nearby property's marketability and value.

It is also highly likely that financing for a nearby property that is impacted directly by the operations may be unattainable due to this external influence and as such marketability and value would be significantly impacted.

iii. Externalities

(A) Definition

Externalities refer to off-site conditions that affect a Property's value.

(B) Standard

The Appraiser must report the presence of Externalities so that the Mortgagee can determine eligibility.

(C) Required Analysis and Reporting

The Appraiser must consider how Externalities affect the marketability and value of the Property, report the issue and the market's reaction, and address any positive or negative effects on the value of the subject Property within the approaches to value.

(1) Heavy Traffic

The Appraiser must analyze and report if close proximity to heavily traveled roadways or railways has an effect on the marketability and value of a site because of excess noise and safety issues.

(2) Airport Noise and Hazards

The Appraiser must identify if the Property is affected by noise and hazards of low flying aircraft because it is near an airport. The Appraiser must review airport contour maps and analyze accordingly. The Appraiser must determine and report the marketability of the Property based on this analysis.

(3) Special Airport Hazards

The Appraiser must identify if the Property is located within a Runway Clear Zone (also known as a Runway Protection Zone) at a civil airport or Clear Zone military airfield and consider the effect of the airport hazards on the marketability when valuing the subject Property.

For Properties located in an Accident Potential Zone 1 (APZ 1) at military airfields, including New Construction, the Appraiser must report the hazard and consider the effect on the marketability when valuing the subject Property and must require compliance with the Department of Defense (DoD) Guidelines.

If the Property is New Construction and is located within a Runway Clear Zone (also known as a Runway Protection Zone) at a civil airport or Clear Zone military airfield, the Appraiser must note that the Property is ineligible for FHA insurance and notify the Mortgagee.

(3) Required Analysis and Reporting

The Appraiser must notify the Mortgagee of the deficiency of MPR or MPS if there is probable or imminent danger of Land Subsidence so that the Mortgagee can determine eligibility or the need to require the purchase of subsidence insurance.

The Appraiser must analyze and report any readily observable conditions of the surface of the land that indicate potential problems from subsidence or the potential for lack of support for the surface of the land or building foundations.

In mining areas, the Appraiser must analyze and report the depth or extent of mining operations and the site of operating or abandoned shafts or tunnels to determine if the danger is imminent, probable or negligible.

(G)Oil or Gas Wells

(1) Operating or Proposed

The Appraiser must examine the site for the existence of any readily observable evidence of an oil or gas well and report the distance from the dwelling.

The Appraiser must notify the Mortgagee of the deficiency of MPR or MPS if the dwelling is located within 75 feet of an operating or proposed well. The distance is measured from the dwelling to the site boundary, not to the actual well site.

(L) Mineral, Oil, and Gas Reservations or Leases

The Appraiser must analyze and report the degree to which the residential benefits may be impaired or the Property damaged by the exercise of the rights set forth in oil, gas, and mineral reservations or leases.

- the infringement on the property rights of the fee owner caused by the rights granted by the reservation or lease; and
- the hazards, nuisances, or damages that may arise or accrue to the subject Property from exercise of reservation or lease privileges on neighboring properties.

(M) Soil Contamination

(1) Definition

Soil Contamination refers to the presence of manmade chemicals or other alterations to the natural soil environment.

Please concern, in earnest your denial for the proposed application of Rodney Paskewitz, Duro Rock. Our family well is 435 feet deep and is fed by various cracks in the bedrock. Any blasting or disturbance in crystalline bed rock may have a profound negative impact on our water quality and supply especially those landowners whose wells are just above the granite in a layer of black sand. There are no guarantees or reassurances that ours or any community wells are protected from damage by the Duro Rock company. Rodney's application is vague and only pertains to Duro Rock. There are no allowances, guarantees or accommodations in writing for any individuals in and around the quarrying area.

In addition to the well concerns we live in an area rich in wildlife habitat. In every sense of the word wildlife. Rare vegetation, seldom seen mammals and waterfowl of great diversity. When the wetland was constructed, we began nesting programs for migratory waterfowl. We have watched one of the most rapid increases in Canada geese, Mallards, and Wood ducks along with nesting Trumpeter swans, Piliated Woodpeckers and American Bitner's. Not just waterfowl but in recent years the population of bobcats has grown to quality numbers.

This is a fragile, rare, environmental setting which is equal to no other. All things listed including our way of life are threatened and so I urge you to deny immediately the Duro Rock Application to blast, cut and crush and store crystalline bedrock from the scenic Minnesota River Valley.

Dear Members of the Redwood County Planning Commission,

The Lower Sioux Indian Community is requesting that the Redwood County Planning Commission require an in-depth environmental review prior to a decision about the Extraction Interim Use Permit for the extraction of boulders, and the mining, processing and stockpiling of granite submitted by Rodney Paskewitz on behalf of Duro Rock Supply Co, and Artesian Properties LLC. The property location is described as the Southwest ¼ of the Southwest ¼, Section 18, T114N, R37W, Swedes Forest Township, in Redwood County MN.

The location of this project within the granite outcrops of the Minnesota River Valley raises many questions regarding the impact(s) of mining on the unique environmental characteristics of the site as well as the historic and cultural properties. The proposed project is located roughly (0.5) mile distance from the Swedes Forest Scientific and Natural Area (SNA) that has known unique and sensitive environmental sites. This SNA is a protected area for the occurrence of the Archean sacred heart granite outcrops, the five-lined and prairie Skinks, and variety of rare (as well as culturally-significant) plants. The loss of granite from this mining operation would include a loss of the shallow depressions in the bedrock. The outcrops are surficial microhabitats for cactus and rare plants only found in this very specialized habitat. Also, an in-depth environmental review should be completed to better understand the project's impacts to ground and surface water resources, the nearby wild and scenic river corridor, endangered and threatened rare plant species, endangered and threated wildlife, wetlands, and air quality changes due to the mining operations.

An Environmental review and identification of mitigation measures is a nominal request for a project that would have permanent impacts to this unique environmental setting found in the Minnesota River Valley.

Attached is a copy of the petition that was circulated on our behalf along with 526 signatures that were gathered in just six (6) short days in opposition to issuing an Extraction Interim Use Permit for the Swede's Forest Quarry.

We strongly oppose this permit based on the fact that Mr. Paskewitz has not presented all the required permits and necessary information needed to consider such a request.

Dear Redwood County Planning Commission,

Duro Rock Supply Co. and Artesian Properties LLC (via Rodney Paskewitz) have submitted an Application for Extraction Interim Use Permit from the Redwood County Planning Commission for the extraction of boulders, and the processing—via blasting, cutting, and/or sawing—and stockpiling of granite on real property as described as the Southwest Quarter of the Southwest Quart, Section 18, Township 114, Range 37, Redwood County, Minnesota, also known as Swedes Forest Quarry.

The property is located in both Swedes Forest Township (Redwood County) and Sioux Agency Township (Yellow Medicine County).

Area landowners and local businesses oppose this project. Together with them, we are asking the Redwood County Planning Commission to deny the application for the following reasons/concerns:

- 1. Harm to human and animal health—including livestock—from extraction activities, including blasting noise and vibrations and the emission of airborne silicas. Families and business owners in the area are concerned that airborne silicas may contaminate crops for human and animal consumption.
- 2. **Storage of explosives used for blasting.** The application lacks information about the type and composition of the explosives to be used for blasting and the potential impacts from their storage and use on humans and the air, water, and soil.
- 3. Decrease in water quantity in area wells due to water withdrawals needed to operate the quarry.
- 4. **Contamination of ground and surface waters, including local wells, due to quarry runoff.** The current application states that wastewater from the extraction process will run off onto the land between the quarry and the wetland.
- 5. Pollution of the wetlands in which the quarry would be located. The Department of Natural Resources, in conjunction with the local Soil and Water Conservation District (SWCD) and Ducks Unlimited, has spent significant resources to enhance these wetlands and increase waterfowl production. The wetland ecology supports various mammals, insects, and aquatic species and acts as a buffer to filter and decelerate the flow of water before draining into the Minnesota River. This wetland area also hosts several educational tours and programs throughout the year. Approving a project will eliminate those educational opportunities.
- 6. **Increased truck traffic on local roads.** This could increase the potential for accidents and require more road repairs and maintenance.
- 7. Potential negative economic impact on area business.
- 8. **The land is currently zoned for agricultural uses.** Industrial extraction of rock and aggregate materials is not an agricultural use and should be deemed an inappropriate land use for zoned agricultural districts.

Please consider my concerns for denying the permit for Rodney Paskewitz, Duro Rock.

The reason I would like the permit denied due to no proof of having the proper permits to start blasting, sawing, excavating and crushing for an interim permit that lasts for 10 years. Isn't interim a short period of time six months to a year? Interim in the Cambridge Dictionary describes the word as something that is meant to be used until something permanent exists.

Secondly, the zoning district is rural vacant land-agricultural. Redwood county has this listed as agricultural. Did the rural vacant land get added because there is no noise regulation for rural vacant land? Since he is planning to mine the granite rock wouldn't it be zoned as industrial mining to represent the operations at this location. Will Rodney have to follow Minnesota's Mining Laws and safety regulations if it is zoned as vacant land?

In Conditions for Permit No. 5, it states: The permit holder shall contact all relevant local, state, and federal authorities/entities and inquire as to whether a permit and/or license is required. If a permit and/or license is required, the permit holder shall apply for and obtain any and all required permits and/or licenses. A copy of all such permits and/or licenses shall be provided to the Redwood County Environmental office upon request. He contacted the Hydrologist and had a Delineation report completed on 11/28/2022 but that is not public in either Redwood County or Yellow Medicine County. Rodney submitted an email from Rebecca Horton to Melisa Barret that states he has a plant species of special concern and another on the state listed as threatened. He has not submitted his avoidance plan or a permit to take for these species. Due to industrial mining, he will perform on his property, it should be assessed for birds, mammals, amphibians and reptiles.

Rodney is planning to go to Yellow Medicine County for his dewatering permit and states "We have applied for a Dewatering permit for up to 5 million gallons per year. No permit has been filed yet in Yellow Medicine County. A local quarry in Granite Falls uses that in one day and has a meter that is recorded weekly to monitor over usage. (That quarry blasts once a week) Rod stated in the planning and zoning meeting on June 30, 2024, he will run from sunrise to sunset six days a week and blast two times a week. The hours of pumping water can be at any time.

Rodney stated in the permit, "runoff filter through grass area then drain into the "lake". Unless a settling pond is required." Five million gallons of wastewater filtering a day will not support any grass. At the other quarry in Granite falls they have 4 settling ponds and flucculants are used to coagulate the silicate particles prior to microfiltration of the water. I do not believe grass would be an equivalent or

environmentally friendly way to keep our type 5 Wetland (that includes wetlands 1-5) clean. It is not a lake. He stated lake as lakes have less regulations mandated.

Granite Falls send 50 percent their rock production out on rail cars. He will be hauling 80,000 pounds of rock or more over county roads by truck. Are our county roads build heavy enough to support the extra tonnage?

Rodney states in his extraction interim use permit that he will remove boulders from the NE part of the property. Rodney has been hauling the boulders out of that area for the last two years along with cutting trees and burning them.

I have mentioned just a few problems I see. There are numerous concerns with permitting Duro Rock at this time with so many requirements and precautions not taken or made public knowledge.

Thank you for your time and consideration and support in denying the permit to Rodney Paskewitz, Duro Rock Co., and Artesian Properties.

Across the board, there is deep and critical concern about the short-sighted proposal to mine, process, and stockpile at Swedes Forest Quarry by Duro Rock Supply Company.
