Tips for title transfers

*If you are selling a vehicle, keep the bottom portion of the title, get the new buyers info and do a report of sale with the state of MN to help ensure you are not liable for anythign that may happen to the vehicle after it leaves your possesion.

*Selling signs off ONCE on the left hand side and nothing more.




^{*}If there is a lien listed on the title, we cannot transfer the title without that lien release signed off by a bank representative.
